MELWOOD:

Scott Gibson, Melwood's Chief Strategy Officer, will brief attendees and answer questions on the organization's Site Plan Application recently submitted to Arlington County for a mixed-use development, including 105 affordable housing units and 18,000 sq. ft. of ground level space at its 23^{rd} Street location, the old Nelly Custis School. The Aurora Highlands Civic Association nominated the building as a historic one to the Historic Affairs and Landmark Review Board (HALRB), and the nomination is moving forward after the review board voted 5-3 for it to continue through the designation process.

Melwood provides training and employment for people with disabilities, and with its partner Wesley Housing will offer affordable housing with a broad range of household sizes and affordable income levels, with a portion of the units for people with disabilities. More information at

FUTURE OF PENTAGON SECTOR PLAN: RIVERHOUSE PLANS RESUBMITTED

Arlington's Pentagon Sector Plan has been overturned by a state court, saying the County failed to provide sufficient public notice before adopting a vision for the next 30+ years of growth in Pentagon City and failed to specify that the plan included the RiverHouse property that would increase height and density limits within the affected areas. The Sector Plan is heading back to the County Board for another vote: County staff said they do not intend to make any substantive changes to their submission, and will recommend the County Board's approval and adopt the exact plan they approved in 22202. Meanwhile, JBGSmith has made changes recommended during Long Range Planning Committee discussions, and resubmitted plans for the Riverhouse development.

BIKE PARK SURVEY FOR HALEY PARK

We received over 60 responses to our survey on a temporary bike park in James Haley Park, and we are in the process of reviewing them. The plan was proposed by Arlington Trails, who joined us at our March membership meeting and outlined their plans for a "sustainable, multi-use, natural surface temporary bike skills park" in James Haley Park. If Haley Park is vetoed, the County, who has been working with Arlington Trails, suggested Fraser Park as an alternative. We will send out a notice when the surveys have been checked out.

SPEEDING ON FORT SCOTT

We have been speaking with the County about ways they could address speeding on Fort Scott Drive. You can see the solution they came up with: a 4 way stop sign at S. Lynn, and crosswalks at that intersection, at S. June, at two S. Grant Street intersections. We hope this will make a difference, we will continue to monitor the traffic when school rresumes. The County avers they could not do anything more forceful as we have not had any accidents/bodily injury/serious crashes (yet).

KENT ST. SIDEWALK PROJECT

Arlington County notified ARCA that they anticipate starting the update on the final design of the Arlington Neighborhood plan for a sidewalk on S. Kent St. in 2 months, and should be complete in 2 – 3 months. They will then schedule timelines, construction schedules and HEY PRESTO! Kent Street may have one block of sidewalks after many, many years of waiting! If those residents of Kent Street who decided not to participate now like the look of the improvements, we are told they may be able to include them...stay tuned.

ASPHALT ART PROGRAM

Arlington is piloting the "Community Canvas Pilot Initiative", a process that will allow community organizations to apply for and implement temporary asphalt murals in areas of the public rights-of-way. 5-6 locations will be selected as pilots for 2024 and will be coordinated with BIDs and civic associations throughout the County through the Arlington Neighborhood Program. They will be located in the areas of a street that are outside of sidewalks, crosswalks, bike lanes, bus stops and travel lanes.

WINDOWS BEING REINSTALLED AT THE HUME SCHOOL!

Lately the Hume School building (our iconic image) has been looking derelict and abandoned: not to worry, their "Sashmeister", an expert window man, will reinstall the windows taken out to be refurbished. The museum will be closed July 13 – 20, but expect a spectacular new look when he is finished!

MEMORIALIZING THE ENSLAVED IN ARLINGTON WITH STUMBLING STONES

This fall, students at Arlington Tech High School will make 15 stumbling stones ("Stolpersteine") that will be placed in locations of enslavement throughout the county, in a collaboration with Arlington Historical Society, the Black Heritage Museum, the County and Schools. The project will identify and recognize the men, women and children who were enslaved in Arlington, and will memorialize their lives with markers installed where slavery occurred. On sidewalks the markers will be bronze plaques, others will be plaques on square blocks. The project is based on the stumbling stones embedded in pavements throughout Europe indicating where victims of the Holocaust lived.

Each year Wakefield High School, through its educational foundation, makes it possible for students from low income families to attend college. This year 36 were selected, and will be enrolled at colleges throughout the US. When you are deciding on annual donations at tax time, this is a very worthy cause close to home.

BUTTERFLY GARDEN IN MET PARK

Butterflies and other pollinators have a new place to call home in Amazon HQ2's Met Park. To attract them, professional horticulturalists and volunteers planted swamp and butterfly milkweed, echinacea, coreopsis and seven other native species in a 250sq.ft. bed. A bench and a dozen tables and chairs are nearby for people to sit and enjoy the view and be there when the monarchs show up.

HONEYBEES VA'S "OFFICIAL STATE POLLINATOR"

"The honeybee is the single most important insect in the founding of Virginia," says Arlington delegate Patrick Hope, who worked to make it Virginia's official state pollinator. There is historical significance to the bee, as the relationship goes back to 1622 when the Jamestown colonists realized the native bees were not pollinating their fruit and vegetables; they wrote to the King asking for some honeybees, and the rest is history.
